In 2017, the Alliance provided fiscal support services for over 160 school-support groups raising funds to benefit schools, and engaged those groups in supporting schools with more limited access to resources. During the year, the Alliance processed and acknowledged more than 3,000 donations on behalf of these groups and disbursed over \$1.9 million for instructional support, scholarships, awards, materials, trainings, extracurricular programs and other school-related activities through our fiscal sponsorship programs.
